Clovelly Annual Parish Council Meeting

The Chair & Vice-Chair will stand down to allow for elections for 2018/19

- Election of Chair: Proposed that Cllr West is re-elected as Chair, Cllr Perham; Seconded: Cllr Garnett; all in agreement Cllr West signed a Declaration of Acceptance of Chair of the Parish Council
- 6. Election of Vice-Chair: Proposed that Cllr Davey is re-elected as Vice-Chair, Proposed Cllr Tucker; Seconded Cllr Perham; all in agreement Cllr Davey signed a Declaration of Acceptance of Office of Vice-Chair of the Parish Council
- 7. Annual Accounting Statement: a copy of the annual accounting statement was read and completed Proposed that the completed statement is sent to the auditor as a correct record: Cllr Perham; Seconded: Cllr Tucker; all in agreement

Clovelly Parish Council May Meeting

- 2. Proposed that the Minutes of the meeting held on the 10th April 2018 should be signed as an accurate record: Cllr Davey; Seconded: Cllr Garnett; all those at that meeting in agreement
- Cllr M Sillifant to sign an acceptance of office of co-opted Parish Councillor postponed until June meeting

At the Chair's discretion PCSO McGovern gave an overview of the 25 crimes recorded in the Clovelly area over the past 12 months; these included assaults, drunk in charge of a vehicle, public order offences and damage to property

PCSO McGovern explained that the number of PCSOs would be drastically reduced to meet budget targets. Proposed that a letter be sent to Devon & Cornwall Police from CPC expressing concern about the proposed reduction in levels of Neighbourhood policing and the effect this could have on rural communities: Cllr Garnett; Seconded: Cllr Perham; all in agreement

PCSO McGovern also gave details of the successful Diversion and Support Team. The team's visits to offenders has seen a 60% engagement rate and a 64% reduction in crime levels

Cllr Julian joined the meeting

 - i) Affordable housing: progress report

Still awaiting the Section 106 agreement from TDC

Proposed that CPC will pay £500 legal fees in the interim if necessary: Cllr West; Seconded Cllr Davey; all in agreement

ii) Devon Air Ambulance Landing Lights

Planning approval granted with slight amendment to location of the lighting column following comment from North Devon AONB

Clerk to contact John Hawkins, Devon Air Ambulance Trust and contractor MAT electrics to arrange the installation

iii) Parish benches, quote for repairs

Proposed that quote from Sonia's Helping Hands for £281 for repairs and maintenance of benches is accepted: Cllr Perham; Seconded Cllr West; all in agreement

iv) Clovelly A39 roundabout

DCC Councillors to make a decision about the sponsorship scheme soon; funding and self-help scheme also available from DCC

Cllr Garnett asked that councillors bring ideas for the roundabout to the next meeting

v) Clovelly Cross Garage sign

TDC could not find a listing for the signs and asked for more location details/ photos Councillors believed that the forecourt of the garage is listed; the signs may be included in the same listing; Clerk to contact TDC again; Cllr Garnett to take photos

vi) Collection of refuse and recycling from Clovelly

Cllr Perham invited Cllr Julian to meet him in Clovelly so he could see the logistical problems involved in collecting waste and recycling; meeting arranged for 16th May

Cllr Inch suggested that Cllr Langmead and TDC Officer Richard Haste are involved as well

DCC own 69 farms and lease them in 7 year blocks; Cllr Julian thought that one farm was being sold; Cllr Inch will check

Cllr Julian questioned Cllr Inch on various Highways issues

Cllr Davey:

There had not been a 'No HGV' sign on the Roundswell roundabout in Barnstaple during the recent road closures as stated by DCC; there are still road closed signs between Holsworthy and

Bradworthy; the diversion routes should have been more clearly signed

Snow warden scheme – for June agenda

Cllr Huxtable:

Road into Clovelly recently closed and no alternative route given

Cllr Goulding by proxy:

Would PC consider paying for an annual skip for the village; Clerk to contact TDC
